I hereby certify that I am the owner or the agent for the owner of the aforementioned dog and that I am authorized to place the aforementioned dog in daycare, boarding, grooming or other services run at or through The Woof Dog Daycare Inc.

The Woof Dog Daycare Inc. requires that all vaccinations (distemper combination, rabies and bordetella) be up to date. I hereby confirm that my dog's vaccinations are presently up to date. I acknowledge that I am responsible to ensure that my dog's vaccinations remain up to date and I understand that attendance at The Woof Dog Daycare Inc. may be denied if vaccinations have expired.

The Woof Dog Daycare Inc. takes reasonable precautions to avoid parasites from being spread within the daycare, however, we highly recommend every dog be on a regular preventative treatment program. The Woof Dog Daycare Inc shall not be liable in the event that the aforementioned dog contacts such condition.

All dogs must be in good health. Dog owner's or agents will verify that the dog is in good health and has not been ill with a communicable condition in the last 30 days. On admission all dogs must be free from any conditions, which could potentially jeopardize other guests. All dogs will require a veterinarian certification of health to be admitted or readmitted after any illness.

I hereby assume all risks inherent in dog daycare activities, hiking, grooming, boarding and the transporting of the aforementioned dog(s) including but not limited to: walking, running, jumping, playing with other dogs, playing with toys, hiking, and grooming. I hereby release The Woof Dog Daycare Inc (its officers, directors, employees and agents) from any liability or claim due to injury of my dog.

If emergency medical treatment is needed I authorize The Woof Dog Daycare Inc to secure veterinary care. I acknowledge that I am responsible to pay all veterinary and other costs relating to the care of the aforementioned dog.

Please note the following for these specific services:

Boarding:

I acknowledge and hereby agree that a deposit equal to one nights boarding is required for booking. The Woof Dog Daycare Inc requires 24 hours notice of cancelation by email or your deposit will be held as compensation.

I acknowledge and hereby agree that in some cases the aforementioned dog might go to a home stay with one of our staff.

Grooming and Spa Services:

I acknowledge and hereby agree that a deposit of \$25 is required for booking. The Woof requires 24 hours notice of cancelation by email or your deposit will be held as compensation.

I understand and hereby agree that in some cases of matting the aforementioned dog may need to be shaved down. In such instances I agree to pay any additional charges that may apply.

I agree that if the aforementioned dog is showing signs of stress The Woof Dog Daycare Inc reserves the right to stop the service. In such an instance I agree to pay a handling charge for the service rendered.

Hiking:

I understand that The Woof Dog Daycare Inc requires 24 hour notice of cancelation by email or I will be charged the equivalent of one hike per dog.

I understand that in some instances such as cold weather, but not limited to The Woof Dog Daycare Inc may have to cancel services with limited notice. In such cases you will not be charged.

I understand that if my dog is not picked up from daycare for a period of three consecutive days without contact the dog will be considered abandoned and will be turned over to the proper authorities.

I understand that The Woof Dog Daycare Inc reserves the right to terminate attendance at any time.

I hereby acknowledge and assume all responsibility for the aforementioned dog and his/her actions while in the care of The Woof Dog Daycare Inc. I hereby release The Woof Dog Daycare Inc (its officers, directors, employees and agents) from any liability or claim due to illness, injury, disease or any medical condition whatsoever with regard to the aforementioned dog, regardless of how they are caused.
